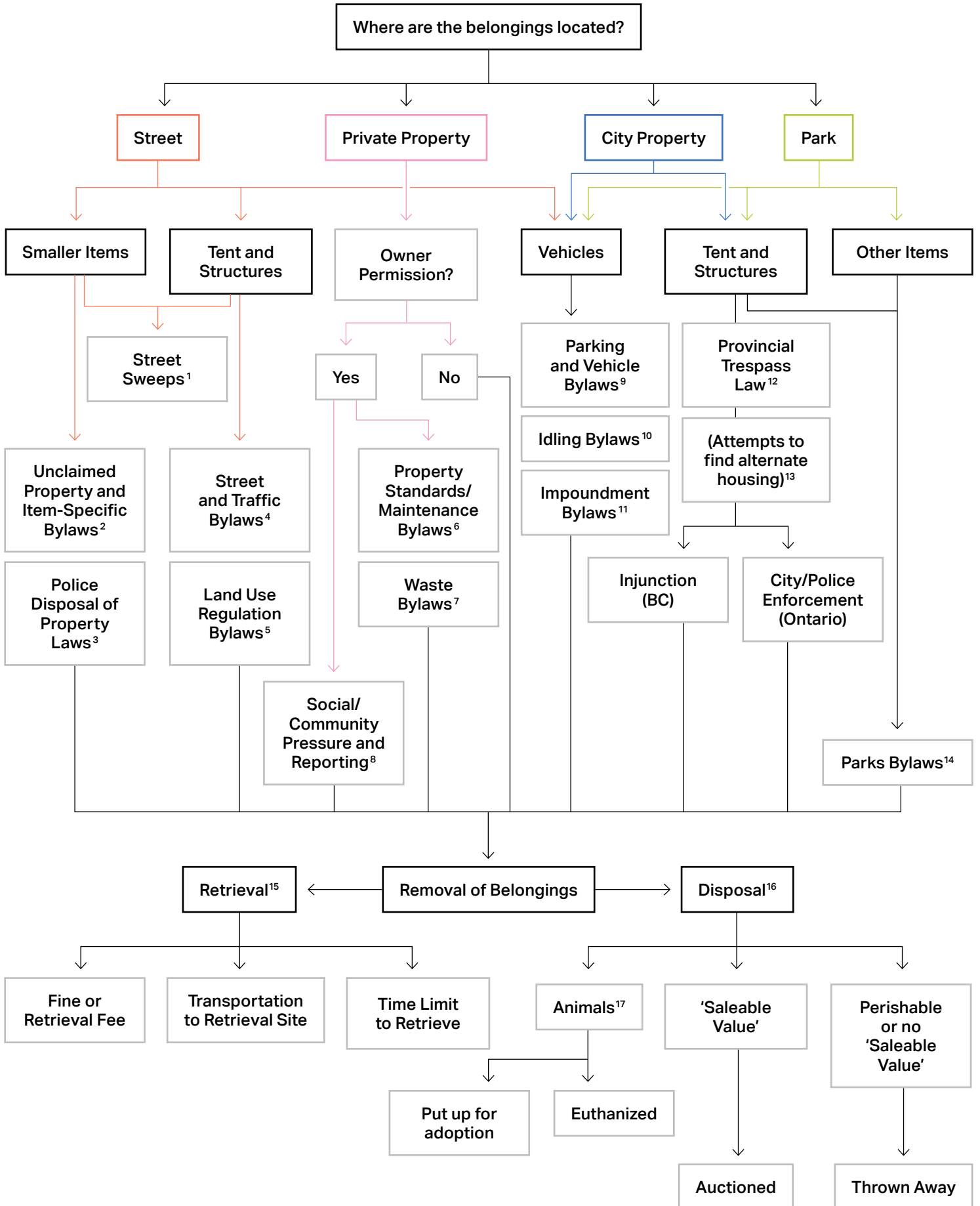


# Regulation of Personal Belongings Flowchart
